

# Aleya Tarver Horsemanship

## Equine Training Agreement

### FEES AND TERMS

**Full training-** \$400.00/ month~ board not included

5 Training rides (including ground-work) a week, weekly 1 hr lessons, grooming/clipping

\*Horses in Full Training must be boarded with Aleya Tarver.

**Half training (in house)-** \$250.00/ month~ board not included

3 Training rides a week/round pen work, bi-weekly private 1 hour lessons, grooming/clipping

**Half training (off property)-** \$300.00/ month~ board not included

3 Training rides a week/round pen work, bi-weekly private 1 hour lessons.

\*These training programs are strictly based on a month to month program. To avoid a laps in training payment is due on the first of every month .

\*If no payment is received by the 5<sup>th</sup>, Aleya Tarver will assume the horse to be out of training and said horse will be removed from schedule.

\*30 day notice is required to discontinue training. There will be no reimbursement of funds should owner decide to take horse home or discontinue training before 30 day contract ends; unless it is trainer mandated.

\* Aleya Tarver offers individual training sessions at the rate of \$45.00 per session for owners who do not want one of the training packages.

### **Lessons and Lesson Programs-**

Regular lessons are \$50 per session. Four lessons = \$200

**Program 1-** Four lessons a month= \$40 per = \$160

**Program 2-** Eight lessons a month= \$35 per = \$280

\*owners of horses in training can add additional lessons @ \$30.00

### **EMERGENCY CARE – ACCIDENTAL INJURY AND/OR ILLNESS**

Should Aleya Tarver feel that any medical treatment is need for said horse, owner will be contacted immediately. If Aleya Tarver feels that it is an emergency (life- threatening) and Aleya Tarver is unable to contact owner, Aleya Tarver is then authorized to secure emergency veterinary and/ or blacksmith care required for the health and well being of said horse. Owner is responsible for any and all fees incurred during the emergency treatment. Aleya Tarver is also authorized, as owner's trainer, to arrange direct billing to the owner of said horse.

Owner's signature certifies and attests to the fact that the owner has read and fully understands all of the terms and conditions outlined herein, and accepts this contract as a legal and binding instrument on behalf of owner, owner's heirs, successors and assigns. This agreement constitutes the entire agreement between the parties. No other agreements, whether verbal or implied are included. In the event it becomes necessary to refer debts arising from this contract to an attorney for collection, or if suit is instituted hereon, owner agrees to pay all reasonable court costs and attorney's fees incurred . Owner further agrees that this contract is made and entered into, in the State of California, in the United States of America and that it shall be interpreted, transacted and enforced under the laws of said state and within the designated country.
